

## Official "66 Days of Winners" Contest Rules

**SPONSOR.** This 66 Days of Winners Contest ("Contest") is sponsored by Phelps County Bank ("Sponsor"). By entering, participants agree to be bound by all of the Contest rules.

**ENTRY PERIOD.** The Contest entry period begins at midnight CST on March 1, 2017 and ends at 11:59 p.m. CST on May 5, 2017.

**ELIGIBILITY.** This Contest is open only to legal residents of the United States and is void elsewhere. Entrants must be eighteen (18) years of age or older at the time of entry. - (1) Phelps County Bank checking account customers will be automatically entered each time they use a PCB debit card to make a purchase between March 1, 2017 midnight CST and May 5, 2017 at 11:59 p.m. CST. (ATM withdrawals do not qualify.)
